**\* Transfer of Ownership** – Ownership of previously registered bicycles WILL NOT be transferred without authorization (written or verbal) by current owner of record.

**\*\* E-Bikes** – The use of electric, including pedal assist, e-bikes is prohibited on Mackinac Island by local ordinance unless the e-bike meets the requirements of the ordinance and the device is being used because of the user's qualified mobility disability as outlined in City of Mackinac Island Code of Ordinances. Only Class-1 E-bikes may be used on Mackinac Island and only by persons with qualified mobility disabilities. Class-2 E-bikes may be converted to Class-1 status by permanently removing the throttle components.
